**CHURCH PENSION GROUP TO HOST CONVERSATION ON
EPISCOPAL PERSPECTIVES ON SOCIALLY RESPONSIBLE INVESTING**

The virtual conversation, part of CPG’s [Insights & Ideas](#) series, will take place on Tuesday, May 14, 2024, from 1:00 PM to 2:00 PM ET. Attendees will discover the approaches these institutions take to invest portfolios to achieve long-term financial objectives while also supporting the values of the Church.
